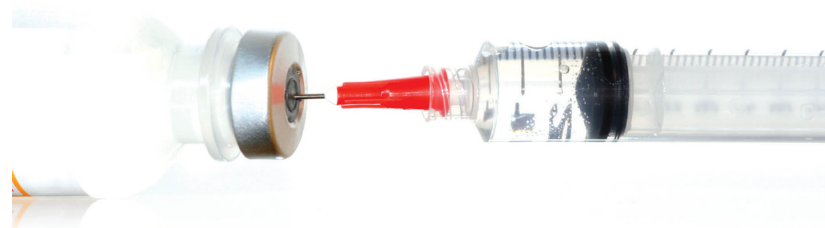

The Panels

Panel 1, moderated by Mary Holland, Esq., a *Vaccine Epidemic* editor and contributing author, examines human rights, ethical and legal issues surrounding vaccination policy in the United States. This panel discusses the conflicts of interest undermining vaccination policy, the very real ethical issues created by vaccination mandates, and the lack of viable recourse for many harmed by vaccines.

Panel 2, moderated by Kim Mack Rosenberg, Esq., a *Vaccine Epidemic* contributing editor and author, presents the personal stories that make the more scientific, ethical and legal arguments in *Vaccine Epidemic* resonate. The guests on panel 2 bring home the fact that vaccines do cause harm to some individuals and that the burdens placed upon the injured and their families are extraordinary.

Panel 3, moderated by Louise Kuo Habakus, MA, a *Vaccine Epidemic* editor and contributing author, examines the current state of science surrounding vaccinations and vaccine safety. The panel discusses why, based on the studies conducted to date, vaccines cannot be declared safe and a relationship between vaccines and a variety of illnesses and effects cannot be dismissed.
